


A FEW WORDS FROM THE DEAN'S OFFICE

Beginning an education at the university level means that a lot of things will be different for you, especially when you compare it to your experiences from secondary education.

The academic work will be more rigorous and demanding. You'll find yourself in a completely new environment - a new country, new settings, new people, and a different way of living. But it's really up to you how well you will manage to embrace those changes.

You'll meet new friends for life, new classmates, new teachers. You'll come up and share new ideas and perspectives. You'll be treated as an adult person who is expected to cope and take responsibility.

A lot of you will experience independence for the first time. No more orders to clean up or to study. No more curfews. No more school bells directing you from one class to another. What you do, when you do it, and how things should be done will be up to you. It means new responsibilities and challenges. Get as much practice as you can with money and time management while you're still in high school. You'll soon realize that time is the most precious commodity you can have.

Here's a sample of what you can expect: schedules will be less structured than those you experienced in high school; some classes take place every day, others two or three times a week, others only once a week. You may also have evening classes for the first time.

Classes are often longer and more intensive. The single forty-five-minute classes you know from the secondary school will take at least twice as long. The group of students attending the same course will also be much bigger.

Some lecture - oriented subjects may be taught in an auditorium setting, with over a hundred students present. This obviously means that the tutor can no longer devote so much of their time only to you.

The volume of work that is required by instructors may be significantly greater than what you are accustomed to in high school. The academic challenges – what you must do to be a successful student will increase by a lot. Higher education is just what the title implies – higher standards, more difficult subject matter, and higher expectations of you as a student.

Can you make it? Totally.

After all, you were admitted to the university. If you weren't capable of meeting the academic challenges, you wouldn't be here. Use our tips. Be present on "How to study medicine" course.

Remember – budgeting time and establishing priorities are among the most difficult challenges for new university students. You must learn to arrange your work schedule in such a way that it allows for an appropriate amount of time for leisure and rest.

In 2012, the U.S. National Committee on Foreign Medical Education and Accreditation (NCFMEA), conducted a review that confirmed that standards and processes used to accredit medical schools in Poland are comparable to those used to accredit medical schools in the U.S. That decision was validated in 2021, as an outcome of the subsequent evaluation procedure.

PUM offers 12 different majors taught in the following faculties:

Students can apply to the first-cycle studies (bachelor), second-cycle studies (postgraduate master), third-cycle studies (PhD), and long cycle studies (graduate master).

Programs for International Students

English Program

Candidates who do not speak Polish can apply to study one of the three programs taught entirely in English:

- 6-year degree in Medicine
- 5-year degree in Dentistry
- 3-year degree in Nursing

Asklepios Program

German citizens who speak fluent English can pursue a 6-year MD degree taught in English and German language.

Asklepios Program is run in association with Asklepios Klinikum Uckermark GmbH in Schwedt. Students of this program train in hospitals in Schwedt/Pasewalk during their fourth, fifth, and sixth years of studies. PUM strives to expand the cooperation in the near future and add hospitals in Brandenburg/Havel and Lübben/Teupitz to the list.

The Plan of Studies includes additional courses taught in German and by German tutors (check out the full plan of study on p. xx).





DID YOU KNOW THAT?

POMERANIAN MEDICAL UNIVERSITY RECTORATE BUILDING WAS DESIGNED
IN 1901-1902 BY WILHELM MEYER-SCHWARTAU AS A BUILDING FOR THE SZCZECIN CITY
ADMINISTRATION. THE ARCHITECT DESIGNED A THREE-WINGED BUILDING OF
IRREGULAR SHAPE WITH A HIGH TOWER ON THE SOUTH SIDE. IT INCLUDED, AMONG
OTHERS, MUNICIPAL SAVINGS BANK, CIVIL STATUS DEPARTMENT, COMMERCIAL COURT,
AS WELL AS CITY POLICE OFFICE. MUNICIPAL ADMINISTRATION BUILDING SURVIVED
THE ALLIED BOMBING OF WORLD WAR II, AND SINCE 1948 SERVES FOR MEDICINE.

Recognition of Professional Qualifications: Directive 2005/36/EC

Directive 2005/36/EC addresses professionals who are fully qualified to practice a profession in one Member State (i.e. who have completed the required training for access to the profession in that country, which for some professions may include both theoretical and practical training) and who wish to practice the same profession or professional activities in another Member State.

Directive 2005/36/EC applies to EU nationals and to nationals of Iceland, Norway, Liechtenstein, and Switzerland (based on an international EU-Swiss agreement).

How does this Directive apply to PUM?

The education and training of future professionals at Pomeranian Medical University adhere to the requirements set in article 34 of the said Directive.

PUM graduates can:

- Apply to third-cycle studies (doctoral/PhD).
- Take the Physicians Final Examination or the Dentists Final Examination (Lekarski Egzamin Końcowy or Lekarsko-Dentystyczny Egzamin Końcowy). Both Exams are available in Polish and English languages.
- Start the internship and exercise their profession outside their home country or the country they received their education from.

II. APPLYING TO POMERANIAN MEDICAL UNIVERSITY







You can apply to study the following majors in the English language:

- In the Faculty of Medicine and Dentistry:
- 6-year MD English Program
- 6-year MD Asklepios Program
- 5-year DMD English Program
- In the Faculty of Health Sciences:
- 3-year BSN English Program



We welcome home and international candidates who speak fluent English (min. B2) and who meet our educational criteria. That means, they studied at least two out of four basic sciences in their secondary school. These are:

- Biology
- Chemistry
- Physics
- Mathematics



Candidates who completed a single subject being a combination of basic sciences, such as:

(Natural) Science

Science: Double Award

are not eligible to apply.

In this cases we strongly recommend BMAT exam in order to change this status.

- You must prove that you completed at least one of these courses on an advanced level (i.e., 2 school years/4 semesters).
- The other course may be taught on a standard level (i.e., 1 school year/2 semesters).
- You received positive (non-failing) numerical final grades in both of these courses ("pass" or "credit" are not considered as grades).
- Your NC (Numerus Clausus)* on your Abitur is not lower then 2.7

FXAMPLE:

- Physics (2 semesters/passing grade) + Biology (4 semesters/passing grade) = you qualify to apply
- Biology (2 semesters/passing grade) + Chemistry (5 semesters/passing grade) = you qualify to apply
- Chemistry (3 semesters/passing grade) + Physics (1 semester/passing grade) = you do not qualify
- Physics (5 semesters/passing grade) + Chemistry (3 semesters/failed) = you do not qualify
- Natural Sciences (6 semesters/passing grade) = you do not qualify
- · Chemistry (2 semesters/pass no grage) + Biology (4 semesters/passing grade) = you do not qualify



The admission is divided into two Steps. Both of them have separate deadlines and requirements, so let's go through each Step... step-by-step!

Balance study and pleasure time

■ Step 1: Apply online

During Step 1, you submit your electronic application and wait for the decision of the Recruitment Committee.

The deadlines for each Program are as follows:

- English Program (medicine, dentistry, and nursing) the recruitment period usually runs from June until August. Exact dates are published on the website each year.
- Asklepios Program (medicine) the recruitment period usually runs from July until August. Exact dates are published on the website each year.

To successfully submit your online application in Step 1, you will need to do the following:

- 1. Go to the online application system, choose your program, and hit the Apply button.
- 2. Fill in your personal details and upload a photo.
- 3. Pay 85.00 EUR registration fee and upload a scan of the payment slip or the PDF report generated by your online banking system.
- 4. Upload a scan of your original secondary school certificate (front and back).
 - 4.1 If a full transcript of your grades is not part of your secondary school certificate, please upload a scan of the transcript that explicitly shows that you
 meet the educational criteria. This document must be stamped and signed by
 your school.
 - 4.2 If the grading scale is not part of your secondary school certificate, please upload a scan of the document that explains a grading scale used in your school/country. This document must also be stamped and signed by your school.
- 5. Upload a scan of your eligibility declaration (unless your eligibility to pursue higher education in the country where you completed your education is explicitly stated on your secondary school certificate).
- 6. Sworn translations of all the documents that were issued in a language other than English or Polish.
- 7. Upload a scan of your English proficiency certificate.
- 8. Upload a scan of your passport or national identity card.

As you'll be working on your application, you can save it at any point and come back to it later. So you do not need to worry about uploading all documents in one go.

When you're ready with your application, don't forget to click the Submit button otherwise we will not receive it!





(?) I'm graduating this year but my secondary school certificate will be issued after the registration deadline. What can I do?

- 1. If you're expected to graduate from a secondary school in the UK or Ireland:
- Upload your transcript of predicted grades.
- Ask your school to issue you the statement that will say what exams you're about to take (course name and level) and when you will receive the results in those exams.

Both documents must be stamped and signed by your school authority. Also should include a grading scale.

- 2. If you are expected to graduate in the IB program:
- Upload your formal IB transcript. The transcript may be sent by IBO or issued by your school.

If your transcript is issued by your school, make sure it's stamped and signed by your school authority.



(?) My secondary education in the subjects required is insufficient. What can I do?

- We accept college or university transcripts if they show that you completed the basic sciences we require.
- We also accept certificates from candidates who successfully completed the basic sciences we require during the premedical course.
- We advise to take BMAT.

We cannot, however, accept courses like Microbiology, Biochemistry, Biophysics in lieu of Biology, Chemistry, Physics.



(?) My Zeugnis der allgemeinen Hochschulreife (Abitur) shows only the latest courses I completed. I studied the subjects you require in previous grades. What can I do?

You may supplement your Zeugnis der allgemeinen Hochschulreife with Zeugnises from earlier grades (in case only one or none of the subjects required is present on your Abitur).

Please be sure that your certificates from class 9 or 10 cover 2 or 4 semesters (depending which subjects and level you need to prove). So a single certificate from the last semester alone will not be sufficient. If your Zeugnis certificates cover one semester only, you will need to provide two or four individual certificates to satisfy the requirements.

Also, please remember to upload a sworn translation to each additional Zeugnis you would like us to consider.



? Can I apply to more than one program?

Yes, you can apply to medicine (English Program or Asklepios Program) and dentistry in one session. You may not, however, apply to the medicine English Program and Asklepios Program at the same time.

- You must submit all of your complete applications before the respective deadlines.
- You must cover a registration fee of 85.00 EURO for each application.
- Please make sure that you marked the right application as a priority

Please note that in case your priority application receives the Conditional Enrolment status, the secondary application will be automatically rejected (as you cannot study two programs simultaneously).



? How can I pay the registration fee?

Please do not send us cash or cheques by post or courier!

Also, please make sure that all transfer fees are covered by the sender (you) so that the amount that reaches us is full and correct. In case someone else is paying your fee, do make sure that your name is mentioned in the transfer description.



What is an eligibility declaration and how can I get it?

Eligibility declaration is a statement proving that the secondary school leaving certificate you were awarded upon completion of your secondary education enables you to pursue higher education at any type of college or university in the country where your diploma was issued.

If your school-leaving certificate was issued by a non-EU or non-OECD country, then you need to submit an eligibility declaration.

You can download the blank form from the Admissions Office website.

You can ask the following authorities to sign the declaration for you:

- the Education Office (Office that supervises pre-university education in a given country)
- the Ministry of Education of the country that has issued you your school leaving certificate

If you hold any of these school leaving certificates, then you do not need an eligibility declaration (this is not a full list):

- Norwegian Vitnemal
- Swedish Slutbetya
- German Abitur der Allgemeinen Hochschulreife
- Irish Leaving Certificate
- British GCF certificates

- Polish Świadectwo Dojrzałości
- International Baccalaureate diploma
- European Baccalaureate diploma




What language proficiency certificates do you accept and why do I need it?

All our programs (including Asklepios Program) are taught in English. We expect our prospective students to prove that their English language skills are at least on level B2 (or higher).

> Please check the Admissions Office website for a full list of the certificates we accept.

When you submit your complete online application, the Admissions Office staff will add grades to the system based on the documents you uploaded. Then, the system will calculate the grade average from two courses we require (Biology, Chemistry, Physics, Mathematics).

The rank list is dynamic. It means that one day you may be on position #12 and next day drop to #65, and a few days later to #97, and so on.



Why is that? As long as the registration period is open, other candidates will keep on submitting their applications that might be stronger or weaker than yours. If their average is higher than yours, then, naturally, your position will drop.

It also works the other way round. If candidates resign, your application will go up.

You may monitor your rank position anytime you want by logging into your account. Since there is a definite number of students we can accept to our programs, you can guesstimate your chances of being admitted.



Depending on your average, your application can receive one of the statuses:

- Conditional Offer you are one of the top candidates on our rank list; all the uploaded scans are in order; you can move to Step 2.
- Waitlist all the seats are currently conditionally offered to other candidates and you may be offered admission if any of the candidates who received a Conditional Offer resigns or fails to fulfill the admission criteria (see Step 2).
- Rejected your application is rejected.

Only the candidates who received the Conditional Offer status go to Step 2.

■ Step 2: Confirm your seat and submit documents

If your application received a Conditional Enrollment status, it means that you will be accepted to the university, on the condition that you:

- Confirm your seat within 7 days.
- Submit original hard copies (i.e., in a paper form) of the following documents before the deadlines set for the given admission period (please check the exact dates on the Admissions Office website):
- 1. Application form (printable from your online account) original
- 2. Application fee payment slip photocopy
- 3. School leaving certificate (high school diploma) Apostilled or legalized $\!\!\!\!\!\!\!\!^\star$
- 4. School leaving certificate transcript (if applicable) original or certified true copy
- 5. School leaving grading scale original or certified true copy
- 6. English or Polish sworn translation of documents mentioned in points 3-5 (if applicable)
- 7. Eligibility declaration original
- 8. English language proficiency certificate original or certified true copy
- 9. English or Polish sworn translation of your birth certificate (if applicable) original
- 10. Health certificate* original
- 11. Vaccination card/booklet* photocopy
- 12. Health insurance* photocopy
- 13. Passport or EU national ID card (copy)
- 14. 2x passport photos

■ Step 2: required documents

Some of the documents we require take time (especially HIV tests, HEPATITUS-B vaccination and English proficiency certificates) so start arranging them well ahead of time!

Certified/True copies

Certified copies mean that the photocopies you submit are true to the original.

We accept certified copies made by:

- Notary Public
- Diplomatic mission officer (consulate, embassy)
- Court
- Lawyer or barrister
- Other legal institutions authorized to certify public documents

We do not accept copies certified by:

- School, college, or university
- Bank
- Post office
- Other public institutions not authorized to certify public documents

Apostille certification and legalization

An Apostille and legalization are two separate procedures that authenticate the origin of a public document (e.g., a school-leaving certificate).

How do you know whether your certificate should have an Apostille or be legalized? It depends on the country where your school-leaving certificate was issued.

If it was issued in a country that is a party to the Hague Apostille Convention - then
your school leaving certificate should have an Apostille stamp attached to it.

In most of the cases, you can get an Apostille stamp at the Notary Public office.

Candidates from the Faroe Islands can have their diplomas authenticated by The Court in the Faroe Islands.



Examples of Apostille certifications

Please note that not all Apostille stamps are always in English. If your Apostille stamp happens to be in e.g. German, you do not need to translate it.

 Similarly, if the country that issued your school certificate is not a party to the Apostille Convention, your document must be legalized.

Since you want to use your documents in Poland, the legalization is done by the Polish consular institutions located in the country where your school-leaving certificate was issued.

Important!

- statements included on your school leaving certificate
- English exam grades on your secondary school leaving certificate
- citizenship of an English-speaking country
- completion of a few courses in English during your secondary education
- completion of a year abroad as an exchange student

- are not accepted in lieu of a formal proficiency certificate.

Health certificate and medical tests

You can download a health certificate blank form from the Admissions Office website. Print it and give it to your family doctor to fill in. Apart from the general information about your health, we also need you to take the following tests:

- Chest X-ray (completed not earlier than 2 years before the date of submission of your application).
- Blood test; complete morphology and AST ALT blood liver test.
- HIV test (completed not later than three months prior to submission of your application).

Vaccinations

We expect you to be vaccinated against Hepatitis B before you commence your studies. That's why you are asked to submit a photocopy of your insurance booklet (or any other document) that would prove that you are immunized against that virus.

If you have never taken Hep B vaccinations before, please submit the statement that you oblige to complete the vaccinations soon after you arrive in Poland.

An example of the declaration. You may type it yourself or download and print the form from the Admissions Office website.

Health insurance

Your health insurance, either public or private, should be valid in Poland. EU/EEA/ Swiss nationals covered by a statutory social security scheme may apply for EHIC (European Health Insurance Card) in their home countries.

Non-EU candidates should provide a copy of their insurance signed with a private or state company. Such a document, proving a scope of medical treatment coverage, should be written (or sworn translated to) Polish or English.

Alternatively, you may submit a written statement saying that you oblige to purchase insurance upon arrival to Poland.



? What kind of health insurance is required in Poland?

When you move somewhere new, things like how much you pay for a filling or the cost of a trip in an ambulance are likely to be far from your mind. But what if we are suddenly hospitalised, break our leg while skiing or need to see a dermatologist? In such cases,

if we do not have insurance, we have to pay for all hospital services from our own pocket. And these are large amounts...

Health insurance is mandatory for all students for the whole duration of their stay in Poland. It is important to remember that each student coming to the University even for one semester studies will be asked to show a proof of health insurance upon arrival.

(?) What is covered by the insurance?

This includes access to primary care, specialist out-patient care, hospital treatment, dental treatment, and ambulance transport. Emergency treatment and treatment in the case of sudden illnesses are generally free of charge. In some cases you may be asked to pay upfront, but try not to do so. If you do have to pay, make sure you receive a proper receipt with every treatment listed.

EU/EEA/ Swiss nationals covered by a statutory social security scheme may apply for EHIC (European Health Insurance Card) which is issued free of charge. More information about how to receive EHIC card:

Main institution in Poland, which is responsible for the health care system is Narodowy Fundusz Zdrowia (abbreviation NFZ). Translation: National Health Fund.

When you seek a help of General Practitioner, you need to present the confirmation of your health insurance, in order to receive a referral to medical specialist.

A referral is a document issued by a doctor who orders tests or allows you to sign up for a specialist doctor. Referrals to specialist doctors are needed as part of NHF care. If you want to consult a specialist doctor free of charge or undergo tests, the referral must also be issued by a doctor under the care of the National Health Fund.

EU citizens without health insurance in their countries of residence and non-EU citizens can sign a health insurance agreement with the National Health Fund (or with one of the private clinics).

Limitations of private insurance are set by the policy you decide on. You can choose a cheap one where you have an access only to basic services, such as visit at general practitioner and some specialist doctors. On the other hand, if you decide on more expensive services, they will most probably include more advanced options, e.g.: hospitalisation, operations, giving birth etc.

Also, please, remember that private companies often set so called delay periods, which means that patients have access to certain services only after longer period of paying the insurance contribution (e.g. 60 days).

That is why we strongly recommend that you obtain the public insurance, which will be respected by Polish National Health Fund.

If you are an international student from a non-EU country, you should purchase health insurance before your trip to Poland. International students are required to present proof of adequate health insurance coverage when applying for a student visa.

Non-EU candidates along with application should provide a copy of their insurance signed with a private/ State company. Such document, proving a scope of medical treatment coverage, should be written (or sworn translated to) Polish or English. Alternatively, a non-EU candidate may submit a written statement saying that he/she obliges to purchase an insurance upon arrival to Poland.

International students and academics are strongly advised to purchase health insurance in their home countries.

Besides the health insurance there is third party liability insurance (obligatory for those who drive a car) and accident insurance, which also may be reconsidered by you.

■ Step 2: You submitted your documents - what's next?

Receive your Certificate of Enrolment

As soon as we receive all of your documents, we will email you your official Certificate of Enrolment. This document will be sufficient for you to apply for a student loan in your home country.

Do you need this certificate in a paper form (for example, to apply for a visa)? Please send us a request by email to recruit@pum.edu.pl.

Alternatively: Receive your Conditional Certificate of Enrolment

Some of the prospective students can be granted conditional enrolment. There are only two instances:

- You submitted all of your documents but are still waiting for your final school leaving certificate (IB, A-levels, Irish Leaving Certificate, etc), you will receive a Conditional Enrolment Certificate.
- You submitted all of your documents but are still in progress with your language exam, you will receive a Conditional Enrolment Certificate.

 Your secondary school leaving certificate needs to be recognized by our local Kuratorium Oświaty (Education Office), you will also receive a Conditional Enrolment Certificate.

You can read more about the secondary school-leaving certificate recognition process on the Admissions Office website.

In both cases, you will receive a deadline to complete the paperwork. It's very important to fulfill your obligations before the deadline expires, otherwise, we will not be able to grant you a full enrollment and allow you to continue your studies with us.

Please note, that if you failed to submit any other documents on time, then you will not be granted a conditional enrolment.

Answer questions to the online poll

There will be an online poll for you to answer (you'll need to log into your account and navigate to the Tasks tab to see the questions):

- The first question will be about the Orientation Days please let us know whether you would like to participate or not.
- 2. The second question will be about the accommodation in PUM Dormitories please let us know whether you would like to stay in our Dorms during the Orientation Days (you may stay at the dorms for a short period of time before your studies, but your temporary stay does not entitle you to reserve a place for the whole academic year).

Pay tuition for your studies

Tuition for the academic year can be paid in full or in two installments.

- 1. The first half of the tuition should be paid by the 1st of October of each year of your studies.
- 2. The second half of the tuition should be paid by the 1st of February of each year of your studies.

Getting around Szczecin

Szczecin has very good public transport. You can move around with buses, trams, or taxis. Rental bikes and scooters are also available.

You may find the following journey planner useful in planning your trip around Szczecin (or other cities in Poland):



It will help you to find a nearby bus or tram stop, tell you which line you should pick, when to transfer to get from A to B, and how long your journey will take. All data is streamed live so you'll need access to the Internet.

Shortly after you begin your 1st-year studies, you will be given a Student Card. It will entitle you to a 50% discount on all public transport (including trains). The discount, however, is restricted by the age – students must not be older than 26.



ດາientation Days and Pre-Courses

All prospective 1st-year students take part in online preparatory courses that normally take place in September. The main aim of the courses is to refresh student's knowledge in Biology, Chemistry, Physics, and to teach some survival Polish.

The courses are subject to an additional fee.

Each prospective student can stay at PUM dorms during the Summer (until mid-September the latest) to take part in the Orientation Days. You will be charged for each night you spend in dorms.

As a prospective student of medicine or dentistry, you must complete epidemiological examinations (salmonella shigella stool test).

The examination consists of:

- a visit to a GP
- delivering stool samples to the Sanitary-Epidemiological Station (one sample per day for three consecutive days)

You will receive from the Dean's Office staff all the necessary documents, i.e, epidemiology booklet, referrals, and examination schedule.

Students of PUM are not health-insured by the university. That's why you need to have proper insurance valid in Poland (arranged in your home country or purchased in Poland). PUM students may see the general practitioner (GP) in the outpatient clinic (located in the same building as the Dean's Office). GPs will help you when you do not feel well or need a referral to the specialist.

If you experience a health emergency, you should go to the emergency room of the nearest hospital. Be aware that waiting times at the hospital can be several hours.

In Poland, some medication is available "over the counter" at pharmacies (not covered by health insurance). Others will require a prescription from your GP.

To see a doctor, you'll need to make an appointment at the registration counter. During your visit, make sure that you have your health insurance card or documents with you, as well as your passport or national ID.

IV. PLAN OF STUDIES

Students of PUM, apart from numerical and non-numerical grades, also receive ECTS points for each completed course.

European Credit Transfer System (ECTS) is a method of measuring your study program as an academic currency. ECTS is used all over Europe and enables you to easily compare study programs and transfer your academic qualifications from one educational institution to another. Its aim is to make programs and the performance of students of higher education more transparent and comparable Europeanwide and to replace or complement the different local (national) standards within Europe.

One year of studies corresponds to a min. Of 60 ECTS-credits and one semester corresponds to a min. Of 30 ECTS-credits. On average, 1 ECTS credit point = 25-30 working hours. The number of credits awarded for each course varies depending on the workload.

Lectures usually range from 45 to 90 minutes and may involve up to 150 students. This type of a course is fairly formal. Although professors may have different expectations, it is generally acceptable to, for example, have a beverage on the desk.

During longer lectures, you are allowed to leave the classroom for washroom breaks without asking for permission. If you arrive late, take a seat as quietly and quickly as possible without disrupting the class. When you have to leave before the lecture finishes, let your tutor know before class begins.

Whenever you're in doubt about the accepted classroom etiquette, ask your tutor/professor during their office hours.

Seminars/Tutorials

Seminars provide an opportunity for a discussion in smaller groups. You will usually be expected to participate in these group discussions. In some cases, you will be graded for your active participation and presentations.

Lahs

Preclinical subjects are taught at the laboratory (lab), which includes hands-on practice (in addition to lectures or tutorials). Labs are conducted in small groups under the supervision of a tutor. In some courses, you must pass the lab in order to get the grade or credit. Labs and tutorials are usually mandatory. In some cases, you will receive a grade for active participation.

Problem-based learning (PBL) classes

PBL approach applies to clinical courses. In a PBL class, rather than listening to a lecture, you will solve problems that you may face in real-life situations. Students mainly deal with real patient cases. Most of the time, you will work in small groups under the general guidance of your tutor.

Online lectures (LMS Moodle e-learning)

Some courses will be streamed online so that the students can safely continue their studies without the need of sitting in a classroom.

CET (Center for Theoretical Exams / University Examination Center)

CET is an interfaculty unit where students can sit their test-based exams fully online. They can do it on-site or remotely at home. The rule to perform exam on-site and from home are different. The center can accommodate 67 students at once.

The are three main methods of evaluation at PUM:

- · Class participation
- Assignments
- Tests
- Exams (oral, written, and practical)

4 ADMISSIONS GUIDE

On the first day of class, your instructor/tutor will hand out a course outline (or a syllabus), which will include such information about the course as the booklist, topics that will be covered, forms of assessment, and requirements for passing the course.

In Poland, university students are expected to take charge of their own learning and success, so be sure to ask your tutor for the syllabus if you missed the first lecture. You are responsible for following all instructions in the syllabus. The professor is also not responsible for any lecture material you may miss during the term due to your absence.

Participation during the classes

In many classes, you will be expected to actively participate by joining the discussions, throwing in your ideas and point of view related to coursework, readings, and assignments. In some cases, you may be graded based on your participation in class.

Assignments

Essays and presentations are very common ways of assessment. Tutors may assign you a term paper that typically is a 10-15 page essay. A term paper is a major undertaking, so make sure you begin working on yours several weeks before it is due. Other kinds of assignments include group projects, oral presentations, and labs.

Tests

The frequency of the tests depends on the subject and your year of studies. On average, you can expect to have 2-5 tests per week.

Final course exams

Students can sit their one exam three times (1 main attempt + 2 retakes). Exams are either theoretical, practical, or both (i.e., you need to pass practical and theoretical exams to complete the course).

You can sit for only one exam per day. If you achieve very good results in a given course, you may be exempt from sitting an exam (this regulation depends on the conditions set by the department that is responsible for a given course).

There are four grades you can get, where 5 is the excellent grade and 2 is a failing grade.

- 1) Excellent 5.0
- 2) Very good 4.5
- 3) Good 4.0
- 4) Satisfactory 3.5
- 5) Sufficient 3.0
- 6) Insufficient / failed 2.0

PUM ACADEMIC NOMENCLATURE

Academic Calendar

The Academic Year Calendar specifies the events that take place during the Academic Year (didactic periods, i.e., Summer and Winter semesters, seasonal breaks, and Summer break).

Academic Year

One academic year equals one full year of study and consists of two semesters (Winter Semester and Summer Semester).

Bursar's Office

The bursar's office is responsible for collecting and analyzing all student charges and fees. It is also responsible for areas including accounts payable, travel claims, as well as invoicing and receipt of all payments.

Credit

A passing mark awarded for satisfactory completion of coursework. Credit is necessary to entitle you to sit the exam (if the course finishes with an exam).

The course is not considered as passed in case you have earned credit but failed the exam.

Depending on the course, you can receive credit with a grade or without a grade. In case your performance during the course was not satisfactory, you can receive two types of credit conditions:

- Green condition (no credit) = no credit awarded by the end of the didactic period
 The course is not failed and the credit may be still awarded if the student compensates for whatever they are missing before the end of the given academic year.
- Red condition (no credit) = no credit awarded by the end of the academic year. The course is failed. If the course finishes with an exam the student is not entitled to sit it. The course is to be repeated next academic year.

Dean

The person who acts as the head of a Faculty.

Vice Dean

The person elected by the students whose main responsibility is to support students in administrative matters.

Dean's Leave

A gap semester or a gap year. During the Dean's Leave, a student does not participate in educational or any studies-related activities. A Dean's Leave is granted on a student's written request addressed to the (Vice) Dean of the respective Faculty.

Students may be granted a one-semester or one-year leave twice during the whole course of studies. The basis and conditions for a Leave are prescribed in PUM Rules and Regulations of Study.

Graduation Ceremony

An official ceremony that is held for the students who have successfully completed their studies. Graduates receive their diplomas during the graduation ceremony.

Professor

Senior academic staff. Often the head of a Chair, Department, or Unit.

Rector's Day

A day off from any didactical activities (no classes, no exams).

Repetition of a Year

When you fail an exam course or a few selected credit subjects, you will not be promoted to the upper year of studies. To continue your studies (as the student of the same year of studies during which you failed a course), you may submit a written request to your (Vice)Dean to receive permission to repeat the year of studies.

Students are allowed to repeat only once the year which was previously failed. The basis and conditions for the repetition of a year are prescribed in PUM Rules and Regulations of Study.

Semester

A semester is one half of an academic year. The academic year at PUM is divided into two semesters: the Winter semester (runs from September to January) and the Summer Semester (runs from February to June).

Syllabus

A syllabus is a basic document for teaching. It outlines the basic elements of a course including what topics will be covered, a weekly schedule, and a list of tests, assignments, and associated weightings. The syllabus lays out the expectations for the quality of work expected from you as a student and shows you how you should prepare for class.

Transcript

An official copy of a student's academic record. It lists all the courses you have taken so far and the grades you have achieved.
