- 2. The certified excuse note comprises of medical reasons (doctor's excuse-health certificate) or the Dean's consent for student's absence.
- 3. Excused absences should be counted in agreement with the lecturer during the block.
- 4. Excused absences lasting more than 2 days does not allow taking the exam.

Clinics will be admitted to the exam (including improved failures).

 Absence from more than two classes is associated with the need to make up the entire block of classes

- 1. Students who have previously passed all the seminars and practical classes in the Genetic Oncology
- 2. Student is required to pass the exam within the time set by the Department of Genetics and Pathology.

Zasady dopuszczające studenta do poszczególnych zajęć w danym roku akademickim*

Principles of attending classes during the academic year*

- All students who have been promoted for the 4-th year of the studies and are included in the dean's
 office list, are admitted to classes.
 - 1) Student will not be admitted to classes in the following cases:
 - a) Being late for classes exceeding 20 minutes;
 - b) Lack of necessary clothing required for the classes, eg. apron, variable footwear (sport or medical) and mask;
 - 2) Student will not be admitted to the classes or will be asked to leave from classes, in the event of noncompliance with the health and safety rules applicable in laboratory of Department of Genetics and Pathology PUM or in case of inappropriate behavior contrary to the study regulations or other kind of behavior regulations applicable at University/ Hospital/ Clinics, disrupting classes, endangering health, life or property, and also in the case of a gross lack of personal culture. Student who has not be admitted to classes or who has been asked to leave from classes has absences in these classes.
- 2. Student is obligated to prepare theoretically for the classes, what can be checked by random assessment.

Warunki i sposoby przeprowadzania zaliczeń przedmiotu i egzaminów Forms of credits, exams

1. Students must present identity document with a photo for the exam.

- 2. During the exam, students are strictly forbidden to have any electronic devices, which could enabled them communicate with other people.
- 3. The exam will be from knowledge presented on lectures, seminars and practical classes and also knowledge from applicable books, which are listed below.
- 4. The exam will be in form of **single choice test** (45 questions). Condition to pass is to obtain 60% of correct answers.
- 5. Unjustified nonaccession for the exam is synonymous with the use of first -term of exam and negative mark.
- 6. Students who get positive mark from exam, have also right to write **one retake** to get higher mark in term of exam of the next group in block of Clinical Genetics.
- 7. Student who has not passed the exam, has the right to write **two retakes**, which will be in form of single choice test.
