*Teaching Methods*

The nuclear medicine course is run in the form of lectures, seminars and classes.

### §2

#### Sposób i formy wyrównywania zaległości, w tym odrabiania zajęć na skutek nieobecności

*Mode and forms of compensation of missed activities*

Attendance of all seminars and classes is obligatory. In the case of absence students are required to attend any missed seminars with an alternative group. Should this not be possible an appointment with the relevant lecturer should be made in order to demonstrate comprehension of material taught as quickly as possible. Two absences from classes are allowed, provided that they are completed at a later date and after agreeing with the lecturer

### §3

*Requirements for course completion in order to sit the credit of exam*

In order to be eligible for the test students are required to have a full record of attendance.

**§4**  
**Zasady dopuszczające studenta do poszczególnych zajęć w danym roku akademickim\***

*Principles of attending classes during the academic year\**

Knowledge of material covered in each seminar and class is required in the following seminars and classes.

The student will not be admitted to the classes in the following cases:

- being late for classes exceeding 20 minutes,
- lack of the necessary clothing required for classes of a given type (white coats and changeable shoes).

The student will not be admitted to the classes or will be expelled from them in the event of improper behavior contrary to the study regulations or other regulations in force at the Department of Nuclear Medicine, behavior disrupting the conduct of classes, threatening health, life or property, as well as in the event of a gross lack of personal culture in the relationship. to the teacher or other people participating in the classes.

Not admitting to classes or asking them to leave them in the cases mentioned above is tantamount to being absent from the classes.

The student completes all unexcused and excused absences on a regular basis after prior arrangement with the lecturer on the forms of making up for classes.

**Warunki i sposoby przeprowadzania zaliczeń przedmiotu i egzaminów**  
*Forms of credits, exams*

The nuclear medicine course ends with a written test (from 50 to 60 questions). In order to be eligible for the test students are required to have a full record of attendance. During the test, it is not allowed to use electronic devices that enable communication with other people at a distance and consult other people writing the test. The retake is made in writing - a single-choice test (from 50 to 60 questions). According to the Study Regulations, the student has the right to a minimum of two retake dates.
