§1

Methods of Teaching

1. Classes of clinical pharmacology course are conducted in the form of seminars and practicals.
2. Attendance at the above-mentioned classes is compulsory. The student presents prepared for each class in accordance with the program provided on the website and on the notice board of the Department of Pharmacology.

§2

Mode and forms of compensation of missed activities

1. Absence from classes can be made up for with another seminar/practicals group, and if not possible, the made up form should be agreed with the assistant responsible for a given class/type of course conducting the classes.
2. In the case of more than 6 teaching hours (lectures, seminars or classes) missed, the student is required to obtain the head of the Department consent to follow the course.
3. Delayed class attendance, i.e. over 20 minutes will be treated as absence from a class.
4. A student unprepared for classes receives an unsatisfactory grade, resulting in failure to complete the given classes.
5. The student has two terms to obtain credit for the missed/failed (absence, unsatisfactory grade) classes, no later than the day preceding the chapter credit test date. The dates are established by a teaching assistant or the head of the department.

§3

Conditions and methods for admitting students to final course assessments and examinations

1. Positive grades from all partial credits form the condition for entry to the final test, obtained not later than the day preceding the test date.

§4

Conditions for allowing students to take part in classes

1. Participation in classes for a given academic year is confirmed by the student inscription on the Dean's list of students and assignment to a specified student group.
2. In the event of inappropriate behavior, which is contrary to the regulations of studies or other regulations binding at the University/Department, behavior disrupting the conduct of classes, endangering health, life or property, as well as in the event of a gross lack of personal culture in relation to the teacher or other students/persons participating in the classes, the student will not be admitted to or expelled from the classes. In the cases referred to above, the student is not admitted to the classes or withdrawn from them, it is tantamount to being absent from the classes

§ 5

Conditions and means for conducting partial course assessments (including the number of retake opportunities for such assessments)

1. Chapter credits (in the test form, 25 questions) will be conducted in accordance with the Study Regulations at PMU for the whole year on the specified date.
2. Failed grade/s obtained from the chapter credit/s can be made-up in 2 re-sit dates set by a teaching assistant of a given group: the first - within 2 weeks from the date of the test results, the second - not later than September 10th of a given academic year.

§6

Conditions and means for conducting final course assessments and exams

1. The final test has the test form. The condition for entry to the final test constitute positive grades/credits from all chapter tests.

§7

Conditions for exemption from some final course assessments or exams

1. The department didactic regulations do not offer the exemptions from credits and the final test.

§8

Forms of admission to the pre-scheduled examination

1. The department didactic regulations do not offer the pre-term final test.

§9
Assessment criteria

1. The verification of the student's knowledge and skills will be based on the grades and activity at seminars and practicals, results of chapter tests and the results of the final test.
2. The 60% of correct answers from the test (both final and chapter) constitute the passing condition.

§10
Additional

1. According to the Order of the Rector of PUM, the possession and use of devices enabling remote communication during the chapter test and final test is forbidden.
2. All comments/objections regarding the test questions should be submitted in writing to the end of the test day. Comments submitted after the above specified time will not be considered.
