§1

Teaching Methods

1. The course “Basics of EBM” comprises 5 hours of e-learning classes in the form of lectures. Completion of the e-learning course “Basics of EBM” is mandatory and the confirmation is the student's login on the platform.
2. The student is obliged to read the content presented in the form of e-learning lectures and supplement the knowledge with the literature provided. The content will be available to students on the Moodle platform (<https://moodle.pum.edu.pl/>, in the tab: “Basics of EBM” 5th Year Medical Students) in the summer semester.
3. The course ends with a written test with a grade conducted in CET.

§2

Principles of attending classes during the academic year*

1. Student whose name is listed on the attendance register in accordance with the decision of the Dean's office is admitted to the course.

§3

Forms of credits, exams

1. Necessary condition to obtain the final credit is to obtain a positive grade from the test (based on 60% of correct answers) carried out in CET or on the Moodle platform by 30.06.2025. The exact date and time of the test will be published on the website of the Department of Hygiene and Epidemiology until April 30, 2025 in the "Information for students" tab, Medical Faculty, "Basics of EBM".

2. For students who did not obtain at least 60% of the points in the test or did not write the test, it is possible to write a retake in two additional dates. The first retake takes place one week after the scheduled test date. The second retake takes place no later than September 10, and its date is announced on the website of the Department of Hygiene and Epidemiology in the "Information for students" tab; Medical Faculty, Basics of EBM.

Circumstances of exemption from credits or exams

1. No exemption from the credit conditions is expected.

Assessment criteria

1. Passing the written test (also retake) takes place when obtaining a minimum of 60% of points.

2. System of conversion of points into grades:

- 1) $\geq 92\%$ - excellent (5,0)
- 2) $\geq 84\%$ - very good (4,5)
- 3) $\geq 76\%$ - good (4,0)
- 4) $\geq 68\%$ - satisfactory (3,5)
- 5) $\geq 60\%$ - sufficient (3,0)
- 6) below 60% - insufficient (2,0)
